Mayor Barton requests Attorney Nikas give an update on 4 ½ Feeder and Liberty Place. Attorney Nikas begins with Feeder Street, they are currently in a Code Violation and no one can locate the owner. We have done a search on the property and he currently has a Worker's Comp lien against the property for about \$30-\$40,000. An option the Village has is to approach the Worker's Comp lawyer

and discuss them assigning us that lien. Then we would have a Sherriff sale. The Sheriff then can sell that property with or without the property owner. This process would skip over the ongoing site plan or nuisance proceedings. Then we would get title of the property and sell it or demolish it. There will be no additional money left over after the sale, but it would be the expedited way to take ownership of the property and clean it up.

Liberty Place, Attorney Nikas spoke with Chief Kibling, there is a problem there with the occupants. The owner died leaving a daughter and son who may be willing to turn over the title of the property allowing us to clean it up. Mayor Barton asks if we are waiting on the daughter and son, Mr. Nikas replies that it is in progress.

Mayor Comment:

Mayor informs the Board that he is currently working with Mike Fiorillo and Attorney Nikas on a property at the end of Kvale Lane, a piece of vacant property to see if we will be deeding over a small portion. The dimensions are needed and details on current infrastructure will also be needed before anything further can be discussed.

Board Comment:

Trustee Horrigan, adds that Moran-Derby Park will be closing on October 31, at dusk. The season went fast, and it was a successful year with nearly zero problems. Some High School soccer games took place, some rec soccer with no where's to park on a Friday night. Almost 300 kids in rec soccer this year, so things are going great. Mayor Barton adds that we had to pick a date in order to winterize the bathrooms, figure out the lights and a few other things before winter hits.
